Dear Justice Frank:

On behalf of Respondents, and pursuant to this Court’s December 14, 2021 order (NYSCEF Dkt. No. 166), we write to provide a third update on the implementation of the City’s new NYC Medicare Advantage Plus Plan (the “MA Plan”). Per the Court’s instruction, we provided an initial update on January 7, 2022, NYSCEF Dkt. No. 173, and a second update on January 21, 2022, NYSCEF Dkt. No. 182.

Below, we provide a further update on the efforts of Respondents and The Alliance to implement the MA Plan. Additionally, we provide a further response to Petitioners’ January 18 filings (NYSCEF Dkt. Nos. 174-79), addressed initially on January 21, and Petitioners’ January 28 submission (NYSCEF Dkt. No. 184), which contained additional misinformation from Petitioners. And we outline the steps we hope to take in the near-term, with the Court’s permission and the lifting of the current preliminary injunction.

Retiree Outreach

Since our January 21 update, we have continued to provide further outreach to retirees in several forms.

1. Webinars

Between “general attendance” webinars for retirees as well as those hosted in partnership with the unions, there have been over 100 retiree education meetings to date, presenting to tens of thousands of retirees. Twelve (12) additional general attendance webinars are scheduled through March, on the following dates: February 4, February 8, February 10, February 15, February 18, February 22, February 24, March 1, March 7, March 18, March 23, and March 29.¹

In addition to these general attendance webinars, we are continuing to schedule and conduct union-specific webinars, and have hosted several more since January 21. For example, a webinar with the Doctors Council on January 27, 2022 was over two hours long, primarily

devoted to responding to retiree questions. The full schedule of upcoming union webinars is below:

- The Uniformed Fire Officers Association has scheduled three additional webinar dates, on February 9, 2022, February 16, 2022, and March 2, 2022.
- The Deputy Sheriff's Association has a session scheduled for February 4, 2022.
- The District Council 37 has sessions scheduled for February 4 and February 20, 2022.
- The United Firefighters Association has another webinar session scheduled for February 16, 2022.

2. Advertisements

We have continued to run advertisements (*see* Jan. 28 Letter, Ex. F) in major publications in the New York and Palm Beach, Florida areas, on the schedule set out in the January 28 submission.

3. Educational Video Series

The Alliance is continuing to develop an educational video series campaign about the MA Plan (including prior authorization, provider network basics, and additional health/wellness program information), and anticipates development concluding in mid-February.

Provider Outreach

Since our January 7 and January 21 updates, Respondents and The Alliance have continued to liaise with providers in numerous ways. In addition to all the outreach set out in the January 7 and January 21 updates:

1. Webinars

Additional provider webinars were conducted on January 14, January 19, January 21, January 26, and January 28, 2022. Further webinars have been scheduled and that schedule is outlined below. As we previously informed the Court, providers have been and will be invited to these webinars in several ways – through monthly provider newsletters, through regularly scheduled touchpoints with providers, via FAQs, and via email as an “e-vite.”

2. Direct Mail Campaign

As mentioned in the January 21 update, we have continued the process of a new direct mail campaign to providers reminding them about the new MA Plan and urging them to review online materials for more information. *See* January 21 Ltr. & Ex. G. In addition to the nearly 500,000 mailings distributed on January 21 to New York providers, more than 300,000 additional mailings (306,060) were circulated to providers in 14 states last week.²

3. Email Campaign

We have also continued an email campaign to providers. Among other things, a provider update email (attached as **Exhibit I**) was circulated to all to all Florida in-network providers on January 28, 2022.

Emails were also sent to providers that have seen City retirees in the past in the following additional states:

4. Telephonic Campaign

Additionally, The Alliance and its dedicated staff of more than 30 associates have continued their telephonic outreach campaign to providers across the country who have recently seen City retirees as patients. *See* Jan. 21 Ltr. at 3-4 (explaining methodology). As of today, The Alliance has undertaken more than 9,000 (9,233) outreach attempts to providers nationwide, including nearly 90 percent of provider targets in New York (2953/3272), 100 percent of provider targets in New Jersey (539/539³), and roughly 5 percent of provider targets in Florida (134/2953).

Response to Petitioners' Recent Submissions

In our January 21 submission, we provided an initial view as to how and why Petitioners' January 18 filings were (and were intended to be) full of misinformation, designed to obstruct implementation of the MA Plan. Since then, Petitioners have confirmed their full-bore opposition to the MA Plan, regardless of how it is implemented. Among other things, Petitioners' website included this guidance to members on January 28:

Send a Valentine or ANY Day Message to Mayor Adams!

1. Copy the following message:

Dear Mayor Adams,

Please Don't Break Our Hearts. Don't put Retirees into the MAPP.

Remember, YOU are a RETIREE Too!

2. Click the **SEND** link below. You will be directed to the **CONTACT THE MAYOR** Web page.

3. **Paste** the message (or enter your own) and if you would like, add your Union and or Agency.

HAPPY VALENTINE or ANY DAY!!

Petitioners are simply not bothering to hide their complete opposition to the MA Plan; their views on implementation must be understood in this light.

An analysis of Petitioners' January 18 submissions regarding providers that allegedly are not going to accept the MA Plan is attached here as **Exhibit J**. As with Petitioners' prior submissions, the vast majority of the cited providers are, in fact, in-network for the MA Plan, or have been recently contacted by the Alliance to advise them about the plan's details.⁴ Nor, other

than what Petitioners are attempting to conjure for the Court’s benefit, is there any mass confusion regarding which providers are in-network or will accept the MA Plan. To the contrary, as with our January 21 submission, less than five percent of the thousands of calls to The Alliance’s call center since January 21 are seeking information regarding provider participation. This is inconsistent with any claim of mass confusion about provider status asserted by Petitioners; that is because those claims are utterly false.

Petitioners’ January 28 letter also previews additional avenues of misinformation.

“Retirees who request printed copies of the MAP’s Evidence of Coverage are being told none are available.” This is pure misdirection – the Evidence of Coverage (EOC) is a *post-enrollment* document not required to be provided in writing until enrollment is complete. The EOC has been posted online as an added benefit to City retirees, but the Court never ordered Respondents to provide written copies of the EOC, as opposed to copies of the updated Enrollment Guide, which we are providing on demand (as well as written copies of the prior authorization-specific flyer).

“The webinars being hosted by the City and the Alliance are little more than one-way commercials.” Again, this is untrue – the vast majority of webinars have included question and answer periods, and all retiree questions posed in chat boxes during webinars are eventually answered by customer service representatives if not addressed during live sessions.

Retirees have been sent the wrong documents. This, unlike Petitioners’ other charges, is true. Between January 7 and January 28, The Alliance fulfilled 6,005 retiree requests for hard-copies of Enrollment Guides. We recently learned that some of those fulfillments accidentally contained materials for different plans. In a large-scale logistical project like this supplemental educational effort, some errors are inevitable, and as soon as The Alliance became aware of this issue, it began immediately contacting affected retirees and overnighting corrected materials. It remains telling, of course, that Petitioners never brought any such issue to The Alliance’s attention, or asked for corrected materials on behalf of retirees.⁵ That is because, of course, Petitioners’ intent is to obstruct, not actually to get retirees accurate information.

Next Steps

Petitioners’ January 28 submission purports to “reiterate” objections to the data transfers needed to implement the MA Plan. As we previously informed the Court during the December 8, 2021 hearing, Petitioners’ objections are baseless. The Court is aware from our prior exchanges that, in advance of the start date of a new health plan, numerous logistical steps are required. A new student might “start” at a school on September 1, but the application, acceptance, and enrollment processes all happen before then, sometimes considerably so; so too with health plans generally, and the MA Plan specifically.

Respondents and The Alliance are eager for the preliminary injunction to be lifted and implementation to begin because significant behind-the-scenes work is required. With apologies if the Court is already aware of some of what follows:

- To start, the City must initiate the enrollment process by processing and transferring certain data from its payroll system to The Alliance for City retirees as a group (save those retirees who have already opted out of the MA Plan). Importantly, this would *not* prevent the ongoing opt-out/opt-in processes from continuing through March 31, 2022, or the plan switching period (through June 30, 2022) from being implemented, because individual retirees' information can and would be re-added to the City's payroll system as needed. After the group data transfer is made, if a retiree later chose to opt out of the MA Plan, that retiree's information could be individually input back into the City's payroll system to allow that retiree to resume his or her prior health care coverage. But the initial group transfer is needed to allow the enrollment process to begin for the vast majority of the City's ~250,000 retirees who have *not* opted out from the MA Plan.⁶
- Once the City makes its initial transfer of payroll data, The Alliance will use that data to prepare enrollment files for the MA Plan, which will be securely submitted to the federal Centers for Medicare and Medicaid Services ("CMS"). Once the enrollments are accepted, health plan materials (member IDs, welcome kits) must be distributed to retirees.

Each of these steps takes time, and must be done in a timely way to satisfy CMS requirements and provide a better, smoother transition for retirees. More to the point: it is hardly irrational or arbitrary to begin enrollment activities for a health plan of the MA Plan's significant size approximately two months before the tentative start date for the plan; indeed, it is common-sensical and completely consistent with the extensive experience of The Alliance's group health teams. To the extent Petitioners have suggested otherwise, we respectfully submit that their position is unsubstantiated and meritless; Petitioners have no background in how enrollment for large group Medicare Advantage plans is or should be handled, and have submitted no evidence or expert opinion on the matter. They have not remotely discharged their burden of showing any irrationality in the City's desired course.

For that reason, we continue to urge the Court to dissolve the preliminary injunction immediately. For all the reasons contained in previous filings – including the extensive, above-and-beyond educational efforts that have been made and will continue to be made, and retirees' ability to opt out of the MA Plan through March 31, 2022 and switch plans through the end of June 2022 – it would not be arbitrary and capricious to begin implementation now.

⁶ The Alliance understands from Respondents that once initial group data transfer commences, it would be extraordinarily difficult to undo the process in any reasonable amount of time.

We are looking forward to discussing the issue with the Court on Monday, and will provide the Court with any updated information before then if we think it would assist the Court's consideration of the issues.

EXHIBIT I

January 2022

NYC Medicare Advantage Plus Plan

Effective April 1, 2022, more than 200,000 Medicare-eligible City of New York retirees will transition to the NYC Medicare Advantage Plus plan. This is an update to the originally communicated effective date of January 1, 2022.

The NYC Medicare Advantage Plus plan is a Medicare Advantage PPO group retiree offering through an alliance between Empire BlueCross BlueShield (Empire) and EmblemHealth. The plan allows retirees to visit any doctor nationally that accepts Medicare while ensuring the provider gets paid their negotiated contractual rate or 100% of the Medicare allowed rate if non-contracted (less any member copay).

Are you in-network?

If you are contracted with your local Blue plan's Medicare Advantage PPO network, you are already an in-network provider participating in this plan. You should continue to see your City of New York retiree patients and submit claims to your local Blue Cross Blue Shield plan.

Out-of-network?

No problem, you can see City of New York retirees and still get paid 100% of the Medicare allowed rate — no contract required:

- You can continue seeing our members as long as you are eligible to receive payments from Medicare.
- Your reimbursement is the same as under original Medicare.
- Our members are not required to obtain a referral before they see a provider.

What are the benefits of the NYC Medicare Advantage Plus plan?

You will notice easier administration with one integrated plan. You no longer need to submit claims to both original Medicare and the Medicare supplemental plan, and you will receive one payment for both Medicare covered and supplemental services.

How to submit claims: You should submit all claims to your local plan for processing:

1. **By mail:** Submit paper claims to your local Blue Cross Blue Shield plan.
2. **By electronic submission:** Submit electronically to your Blue Cross Blue Shield plan.

Please be sure to include:

- The amount the member paid. The member's copay amount will be noted on their ID card for commonly used services.
- The three-digit alpha prefix N6Y that precedes the member ID number listed on the front of their card.

Florida Blue Medicare is an Independent Licensee of the Blue Cross and Blue Shield Association. The NYC Medicare Advantage Plus plan is offered through an alliance between Empire BlueCross BlueShield Retiree Solutions and EmblemHealth. Empire and EmblemHealth have come together to create a new, customized, fully insured Group Medicare Advantage program for the City of New York.
